We, the undersigned persons of the age of eighten or more, as incorporators of a corporation under the IDAHO adopt the following articles of BUSINESS CORPORATION ACT, Incorporation for such corporation:-

ARTICLE 1 - NAME.

The name of the corporation is HAZARDOUS WASTE CONSULTING AND REMEDIATION INC.

ARTICLE 2 - DURATION.

The period of it's duration shall be perpetual.

ARTICLE 3 - PURPOSES.
