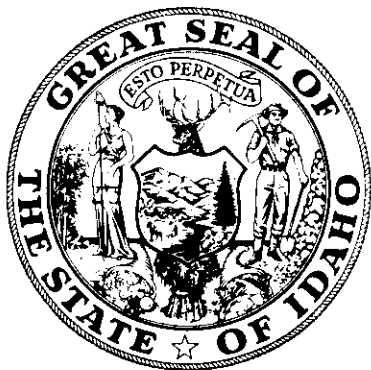

ARTICLES OF INCORPORATION

OF

FOUR STAR LOGGING, INC.

The undersigned, acting as incorporators under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is Four Star Logging, Inc.

ARTICLE TWO

DURATION

The duration of the corporation shall be perpetual.

ARTICLE THREE

PURPOSES AND POWERS

The purposes of the corporation and its powers are the following:

1. The corporation shall have all powers and purposes specified by the Idaho Business Corporations Act.

ARTICLE FOUR

STOCK

The aggregate number of shares which the corporation shall have authority to issue is 10,000 in number and shall be of \$1.00 par value. Said shares of stock shall be fully paid for before being issued, and after issuance shall be nonassessable.

LOCATION
