ARTICLES OF INCORPORATION
OF
EVERYONE'S GARDEN, INC.
An Idaho nonprofit corporation

The following Articles of Incorporation are
hereby submitted and certified pursuant to Section 30-3-17 of
the Idaho Nonprofit Corporation Act:

FIRST

The name of the corporation is Everyone's
Garden, Inc.

SECOND

The corporation is a nonprofit corporation.

THIRD

The period of duration of the corporation is
perpetual.

FOURTH

The purpose for which the corporation is formed
is to assist in the philosophical education and spiritual
growth of those members of the community exhibiting need and
promise and to conduct all other business associated
therewith.

FIFTH

The corporation shall have members, under
membership requirements as set forth in the corporation's
bylaws.

SIXTH

No part of the net earnings of the corporation
shall inure to the benefit of, or be distributable to its
members, trustees, officers, or other private persons, except
that the corporation shall be authorized and empowered to pay
reasonable compensation for services rendered and to make ^{IDaho SECRETARY OF STATE} CUST# 33836

payments and distributions in furtherance of the purposes set forth in Article Fourth hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

SEVENTH

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

EIGHTH

The street address of the corporation's initial registered office shall be 216 South Second Avenue, Sandpoint, Idaho 83864. The initial registered agent of the corporation shall be Steve McClintock, at such street address.
