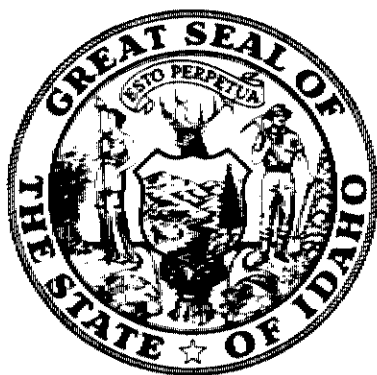

ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of twenty-one or more, acting as incorporators of a corporation under the Idaho non-profit corporation laws as of this date, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is Heritage Baptist Church, Incorporated of Coeur d' Alene, Idaho.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The corporation is a non-profit corporation.

ARTICLE FOUR

The purpose of HERITAGE BAPTIST CHURCH, INC. shall be to promote the worship of the Triune God: Father, Son and Holy Spirit; to proclaim and teach the Word of God; to earnestly contend for the faith; to preach the gospel of the Lord Jesus Christ in this community and around the world in obedience to the Savior's commission; to win the lost to a saving knowledge of the Lord Jesus Christ; to provide opportunity for growth in the grace and knowledge of the Lord Jesus Christ; to assist and encourage believers in the dedication of their lives for definite Christian service; and to administer the ordinances of the church as set forth in the New Testament; and to generally strive for the advancement and progress of the church. We will accomplish this purpose through various, scripturally-based ministries.

ARTICLE FIVE

The street address of the initial registered office of the corporation is 3655 N. Government Way, Coeur d' Alene, Idaho. The initial registered agent at such address is the Rev. Duane Grimes.
