

# ARTICLES OF AMENDMENT (Non-profit)

To the Secretary of State of the State of Idaho  
Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned  
non-profit corporation amends its articles of incorporation as  
follows:

**1. The name of the corporation is:**

Crossroads Christian Church of Boise, Idaho Inc.

**2. The text of each amendment is as follows:**

- Article One – The new name of the corporation (congregation) shall be Real Life Ministries-Boise, Inc. Purpose of said corporation for religious purposes under section 501(c) (3)
- Article Two – Terms shall exist as a perpetual corporation
- Article Three – Registered Office – 600 N. Curtis Rd. Suite 247 Boise, ID 83706
- Article Four – Statement of Faith-Non-negotiable, The Bible, God, Jesus, Holy Spirit, Salvation Spiritual Gifts, People, Eternity, Eternal Security, End Times, Leadership Model, Priesthood of Every Believer, Communion, Stewardship
- Article Five – Governance, The Corporation shall remain a free self-governing organization
- Article Six – Directors, The Elders of Real Life Ministries shall be the directors of Corporation according to the Biblical qualification and appointed according to the Bylaws.
- Article Seven – Membership, The Corporation is a church with membership managed by the Elders.
- Article Eight – Dissolution, The Church is dedicated to the purposes stated in Articles one and four. Upon dissolution or liquidation all assets shall be distributed for one or more of exempt purposes within the meaning of 5019(c) (3). Assets will be distributed to the Church Development Fund of Irvine, California.
- Article Nine – Amendments, This Constitution may be amended at any regular monthly meeting of the Board of Elders in good standing.
