



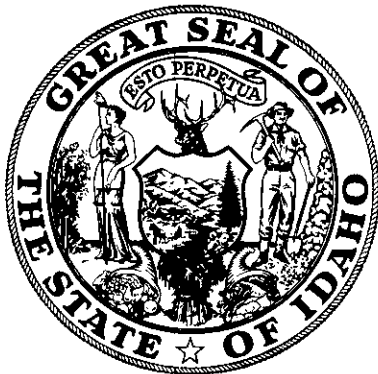
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION  
OF  
SANITARY DISPOSAL, INC.

The undersigned, acting as incorporator of the corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I.

The name of the corporation is:

"SANITARY DISPOSAL, INC."

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purpose or purposes for which the corporation is organized are to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000) shares, having a par value of One Dollar (\$1) per share.

ARTICLE V.

The address of the initial registered office of the corporation is 1312 Eighth Avenue, Lewiston, ID 83501, and the name of its registered agent at such address is Jack R. Little.

ARTICLE VI.
