KNOW ALL MEN BY THESE PRESENTS:

That the KENDRICK-JULIAETTA COMMUNITY DEVELOPMENT ASSOCIATION, INC, a nonprofit group does hereby form a nonprofit corporation under and pursuant to the laws of the State of Idaho under the provisions of Chapter 3, Title 30 of the Idaho Code, entitled Nonprofit Corporations and does hereby certify as follows:

FIRST

The corporate name of this nonprofit corporation shall be:
KENDRICK-JULIAETTA COMMUNITY DEVELOPMENT ASSOCIATION, INC.

SECOND

This nonprofit corporation is organized exclusively for religious, charitable, scientific and/or educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

THIRD

The purposes and objects for which said corporation inasfar as consistent with Section 501 (c) (3) of the Internal Revenue Code is formed are as follows:

- (a) To promote the maintenance and improvement of infrastructure both hard and soft, including communication cultural events and education in the Kendrick-Juliaetta Area
- (b) to Promote the retention and expansion of existing business in the Kendrick Juliaetta Area.
- (c) to promote diversification of the economy of the community of Kendrick-Juliaetta Area and surrounding area.
- (d) To purchase, own property, real and personal to serve the purpose of this organization.

- (e) To obtain grants and funding to further the projects and purposes of this organization.
- (f) to hold title to all property which said corporation may now own or may hereafter acquire, and for said purpose and to that end, to buy, sell, acquire or dispose of real property, and otherwise do all acts and things necessary or convenient in or about the conduct, management or carrying on of such activities, objects, and purposes.
- (g) to make, perform and carry out contracts and agreements for any lawful purpose to the extent permitted by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code.
- (h) to transact any and all lawful business for which nonprofit corporation may be incorporated under Idaho Code Chapter 3, Title 30.
- (i) to comply fully with Section 501 (c) (3) of the Internal Revenue Code and not to carry on any activity not permitted by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code.

FOURTH

This corporation shall have perpetual existence.

FIFTH

The principal place of nonprofit corporation shall be in the State of Idaho and the address of the nonprofit corporation shall be P O Box 204, Kendrick, Idaho 83537.

SIXTH

This nonprofit corporation membership shall be composed of interested citizens from the community of Kendrick-Juliaetta including individual members and businesses.

SEVENTH

This nonprofit corporation is not organized for pecuniary profit and shall have no powers to declare dividends and shall not have or issue any capital stock. No individual shall have any interest whatsoever in the assets of the corporation.

That the right and power to adopt, repeal, alter, rescind and amend the bylaws of this corporation and to adopt new bylaws is hereby expressly conferred upon the membership of this nonprofit corporation as provided by the laws of the State of Idaho and in conformity with the provisions for exemption from Federal Income Tax under Section 501 (c) of the Internal Revenue Code.

THIRTEENTH

Upon the winding up and dissolution of this Nonprofit Corporation after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.
