ARTICLES OF INCORPORATION

OF

ROCKFORD CONSTRUCTION, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation shall be ROCKFORD CONSTRUCTION, INC.

ARTICLE II.

Duration

The duration of said corporation shall be perpetual.

ARTICLE III.

Objects, Purpose and Powers

That the nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, and to do any or all things herein mentioned, as fully and to the same extent as natural persons might or could do, in any part of the world, to-wit:

- a) To operate, engage in, maintain and conduct a general office business, usually transacted in connection with a construction business.
 - b) To acquire by lease, purchase, gift, devise, contract,

concession or otherwise and to hold, own, develop, explore, improve, operate, lease, enjoy, control and manage, including the power to mortgage, grant, lease, rent, sell, exchange and convey or otherwise dispose of, without limitation, any and all real estate, lands, options, grants, land patents, franchise, rights, privileges, easements, tenements, estates, hereditaments and interest in property of every kind and nature.

- c) To acquire and make payment for in cash or in stock or bonds of the corporation or by undertaking and assuming obligations and liabilities of the transfer or in any other way the good will, rights and property, the whole or any part thereof, of any business, firm, association, or corporation; to hold or dispose of the whole or any part thereof of the business so acquired and to exercise all the powers necessary and convenient to conduct and operate the management thereof.
- d) To manufacture, purchase or acquire in any lawful manner and to hold, own, mortgage, rent, lease, pledge, sell, transfer or in any manner dispose of, and to deal and trade in goods, wares, merchandise, and property of any and every class and description and in any prt of the world.
- e) To enter into, make, and perform contracts, licenses, and franchises of every kind with any person, firm, association or corporation, municipality, body politic, county, nation or territory, state, government, or colony or dependency thereof,

and without limit as to amount, to draw, make, accept, endorse, discount, execute and issue promissory note, drafts, bill of exchange, warrants, bonds, debentures, and other negotiable or transferable instruments and evidences of indebtedness, whether secured by mortgage or otherwise, so far as may be permitted by the laws of the State of Idaho.

- f) To do any or all of the things herein set forth to the same extent as natural persons might or could do in any part of the world, as principals, agents, contractors, trustees or otherwise, and either along or in company with others.
- g) To do any other transaction, act, duty, or purpose for which a corporation may be created for the carrying on of any or all types of lawful business practices under the Idaho Business Corporation Act.

ARTICLE IV.

Capital Stock

The amount of the total authorized capital stock, all of one class, of this corporation is TEN THOUSAND DOLLARS (\$10,000.00), divided into TEN THOUSAND (10,000) non-assessable shares of common stock of the part value of ONE DOLLAR (\$1.00) each.

ARTICLE V.

Registered Office
