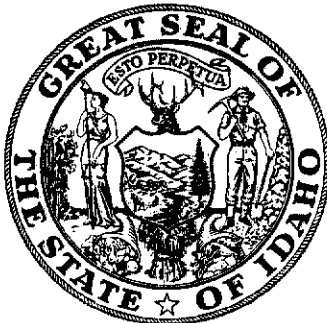

The undersigned, acting as incorporator pursuant to Idaho Code Section 30-1-53, hereby forms the following corporation, which shall be controlled by and have the powers enumerated in the Idaho Business Corporation Act.

I

The name of the corporation is LYLE'S CHEVRON, INC.

The period of its duration is perpetual.
