a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed  
in this office on the **twenty-seventh** day of **June**, 1952

original articles of amendment, as provided by Section 30-146, 30-147 and 30-148, Idaho Code, amending Article Fifth: increasing the authorized capital stock to \$50,000, divided into 500 shares of the par value of \$100 each; amending Article Sixth: the Board of Directors to consist of six directors, each of whom must be a share holder; the number to be increased or decreased from time to time, provided the number of directors constituting a board shall not be less than five (5) nor more than eleven (11),

and that the said articles of amendment contain the statement of facts required by law, and are  
recorded on Film No. **75** of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have  
been amended accordingly.

sworn each upon oath, depose and say:

WM. W. KNOX is the duly elected, qualified and  
acting President, and that MARY S. KNOX is the duly elect-  
ed, qualified and acting Secretary of The Glenns Ferry  
Bank, Limited, a corporation organized and existing under  
the laws of the State of Idaho; that on June 14, 1952,  
pursuant to the call for a special meeting of the stock-  
holders of The Glenns Ferry Bank, Limited, issued by the  
Board of Directors on May 6th, 1952, and pursuant to writ-  
ten waiver of notice and consent to the time, place and  
purpose of the meeting executed by all of the stockholders  
of said corporation as appears in the minutes of the meet-  
ing, of said stockholders, which waiver and consent stated  
among other things that one purpose of the meeting was to  
amend sections "Fifth" and "Sixth" of the Articles of Inc-  
orporation of the Glenns Ferry Bank, Limited, as amended  
by the Articles of Amendment to the Articles of Incorporation  
of the Glenns Ferry Bank, Limited, and filed in the office  
of the Secretary of State of the State of Idaho on January  
18th, 1934.

The meeting of the stockholders of said corporation  
was duly convened and held, whereat all and every of the  
issued and outstanding shares of stock of said corporation  
were present and represented; that at said stockholders  
meeting the undersigned Wm. W. Knox was the Chairman and

and the undersigned Mary S. Knox was the Secretary; that at said meeting by resolution duly presented and unanimously adopted by the affirmative vote of all of the issued and outstanding shares of stock of said corporation, section "Fifth" of the Articles of Incorporation of the Glenns Ferry Bank, Limited, as amended by the Articles of Amendment to the Articles of Incorporation of the Glenns Ferry Bank, Limited, and filed in the office of the Secretary of State of the State of Idaho on January 18th, 1934, was amended to read as follows:

"FIFTH

That the total authorized number of Par value shares of this corporation shall be Five Hundred (500) shares, each of the Par value of One Hundred Dollars (\$100.00), and of the aggregate Par value of Fifty Thousand Dollars (\$50,000.00), which said shares shall be common stock."

That at said meeting by resolution duly presented and unanimously adopted by the affirmative vote of all of the issued and outstanding shares of stock of said corporation, section "Sixth" of the Articles of Incorporation of The Glenns Ferry Bank, Limited, as amended by the Articles of Amendment to the Articles of Incorporation of the Glenns Ferry Bank, Limited, and filed in the office of the Secretary of State of the State of Idaho on January 18th, 1934, was amended to read as follows:

"SIXTH

The Board of Directors shall consist of six directors, each of whom must be a share holder; during their term of office, or thereafter, the number of directors may be increased or decreased from time to time as may be provided by the by-laws; provided, however, that the number of directors constituting a board shall not be less than five (5) nor more than eleven (11).

All of which appears upon and is of record in the minutes of said meeting duly recorded in the minute book of said corporation.
