The undersigned, acting as incorporator, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, does hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be VALLEY VIEW GROCERY, INC.

ARTICLE II

The purposes for which said corporation is formed are:

A. To merchandise, sell, offer for sale and distribute at wholesale and retail, foods and food stuffs of all kinds and descriptions whether in bulk, package, bottle or can, including beverages of all kinds and for all purposes, and to generally deal in groceries and grocery products; and to deal in gasoline and all other petroleum products, all kinds of oils and products used for motor fuel or lubrication, all manner of accessories and appliances to be used on motor vehicles of every description, and other articles and items useful to or desirable for patrons of a service station.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

The address of the Corporation's initial registered office shall be 440 Broadway, Ucon, County of Bonneville, State of Idaho and the name of its initial registered agent at such address is Sally Khatchatourian.

ARTICLE V

The capital stock of the Corporation shall be one hundred (100) shares of common stock, without par value. The capital stock of the Corporation shall not be assessable.
