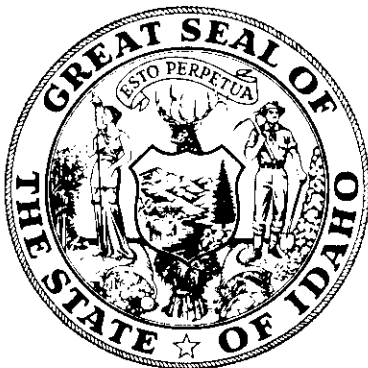

ARTICLES OF INCORPORATION
OF
EAST COUNTY CHRONICLE, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. The name of the corporation is EAST COUNTY CHRONICLE, INC.
2. The period of its duration is perpetual.
3. Its purpose is to print, publish, circulate or otherwise deal in a newspaper or other publications, and generally to carry on the business of newspaper proprietor and publisher and other business not forbidden by law.
4. The corporation shall have authority to issue fifty shares of common stock, all of one class, of no par value.
5. The address of the initial registered office is 101 Main Street North, Kimberly, Idaho, 83341. The name of the initial registered agent at such address is RosaLea Whitehead.
6. The number of directors constituting its initial Board of Directors is five, whose names and addresses are as follows:
