ARTICLES OF INCORPORATION

OF

ASHLEY ESTATES WATER ASSOCIATION, INC.

The undersigned, acting as incorporators under the Idaho Non-profit Corporation Act, hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Ashley Estates Water Association, Inc.

ARTICLE II

The corporation is a non-profit corporation.

ARTICLE III

The duration of the life of this corporation shall be perpetual.

ARTICLE IV

The purpose of the corporation is to provide water service to private users for beneficial use.

ARTICLE V

The initial registered office is at 1410 Lincoln Way, Coeur d'Alene, Idaho, 83814, and the name of the corporation's initial registered agent at such address is Raymond Vaudreuil.

ARTICLE VI

The initial Board of Directors shall consist of three members and the number of directors may be increased by amendment to the by-laws to a total of five (5), with any further increase in the number of directors to be made only by amendment of the Articles of Incorporation.

ARTICLE VII

The incorporator is Raymond Vaudreuil, whose street address is 1410 Lincoln Way, Coeur d'Alene, Idaho 83814.

ARTICLE VIII

The corporation may issue certificates evidencing membership rights.

ARTICLE IX

Upon dissolution of the corporation, its assets are to be sold and the proceeds distributed to the current members of the Association.


The above directors shall hold office until the first annual election of directors, and such election shall be by the membership of the corporation.
