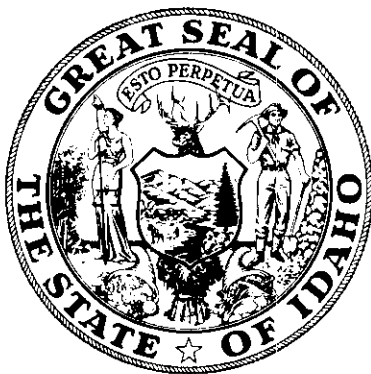

ARTICLES OF INCORPORATION OF IDAHO

MIRACLES, INC.

I, the undersigned, being a natural person of full age and a citizen of the United States, hereby incorporate myself under the Idaho Non Profit Corporation Act §30-301, et seq. I.C.

ARTICLE I

The name of the corporation shall be MIRACLES, INC.

ARTICLE II

The corporation is formed as a non profit corporation.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

The purposes of the corporation are:

- a. To promote horsemanship and to conduct any and all related activities incident thereto for handicapped, disadvantaged and disabled individuals.
- b. To engage in activities characteristic of charitable and benevolent organizations, generally.
- c. To acquire and hold, develop, improve, subdivide, lease, construct, exchange, mortgage, sell, convey, finance or otherwise dispose of or deal in, real estate.
- d. To borrow or raise money for any of the purposes of the corporation and in connection therewith to grant collateral or other security, either alone or jointly with any other person, firm, or corporation, and to make and issue promissory notes, drafts, bonds, debentures, and other evidences of indebtedness; and in general, to any and all things and to exercise any and all powers which

now or hereafter might be lawful ofr a non profit corporation to do or exercise, under and in pursuance of the Idaho Non Profit Corporations Act, or any other law which ow or hereafter might be applicable to this corporation.

ARTICLE V

The management of the affairs of the corporation shall be in its members.

ARTICLE VI

The officers of said corporation shall be:
