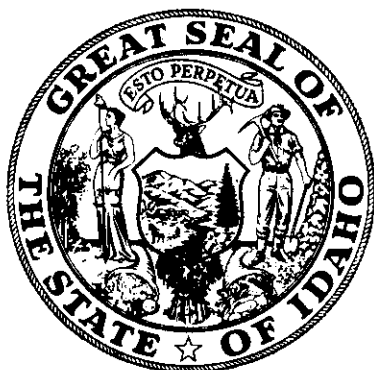

I. The undersigned natural person of the age of twenty-one years or more, acting as incorporator under the Idaho Business Corporation act, adopt the following articles of incorporation:

Article I. The name of the corporation is Jordan Brothers Development Corp., and it's duration is perpetual.

Article II. The initial registered office of the corporation in the state of Idaho is Rt. 1, Wilder, Idaho.

Article III. The purpose and powers of the corporation are.

1. To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, sell, use, develop, construct improvements upon, renovate, repair, and otherwise deal in and with, real or personal property, or any interest therein, wherever situated.

2. To engage in any lawful activity for which corporations may be organized under the Idaho Business Corporation Act.

3. To engage in any lawful activity and to do anything in the operation of this corporation or for the accomplishment of any of it's purposes or for the exercise of any power herein set forth which shall appear necessary or beneficial to this coporation in connection therewith.

Article IV. The amount of total authorized capital of thie corpora-tion shall be:

1. Six thousand shares of common stock, with \$5.00 par value.

2. No share holder or other person shall have a pre-emptive right to acquire any treasury shares, presently authorized shares, or shares or other securities, any corporation may be issued and sold from time to time by direction of the Board of Directorsto such persons, and upon such terms and conditions as the Board of Directors deem proper and advisable.

Article VI. The corporations shall indemnify, exonerate, reimburse, or defend any present or former director, officer, employee, affiliate, agent or contractor of this corporation for expenses, claims, liabilities, indebtedness, penalties, damage or injury incurred by or caused by them in such capacity except for knowing unauthorized acts or defalcations not ratified, confirmed or adopted or the benefit thereof received by this corporation.

Article VII. The corporation shall not transact any business or incur any indebtedness until there has been paid into the corporation for the issuance of shares consideration of at least \$1000.00.

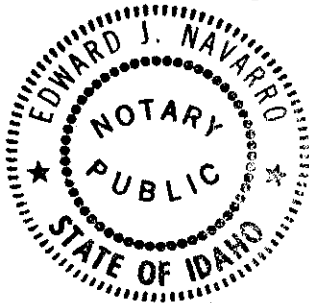
