ARTICLES OF INCORPORATION
OF
COEUR d'ALENE PSYCHIATRIC SERVICES, P.A.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is COEUR d'ALENE PSYCHIATRIC SERVICES, P.A.

II.

The purposes for which the corporation is formed is to engage as a professional service corporation in the practice of psychiatry and in the practice of clinical social work, and to engage in any other lawful act or activity for which a corporation may be organized under the Idaho Business Corporation Act. Such professional services shall be rendered by persons so licensed or authorized to practice in the State of Idaho.

III.

The period of existence of this corporation shall be perpetual.

IV.

The location and post office address of the registered office of the corporation in the State of Idaho is 1119 Ironwood Parkway, Suite 101, Coeur d'Alene, Idaho 83814. The name of the registered agent at that address is John J. Callahan.

V.

The total authorized number of par value shares of stock is 50,000. The par value of each authorized share shall be \$1.00, and the aggregate par value of the total authorized number of par value shares is therefore \$50,000.00. There are no shares without par value.

VI.

VII.

The business of the corporation shall be managed and conducted by a Board of Directors of not less than two (2) nor more than seven (7) directors. The Board of Directors shall be elected in the manner set forth in the By-Laws.

The Board of Directors shall have authority to issue bonds, debentures, or other obligations of the corporation from time-to-time for any of the objects or purposes of the corporation and to secure them by mortgage, deed of trust, or pledge of any or all of the real and personal property, rights, privileges, and franchises of the corporation wheresoever situated, acquired, and to be acquired, and to sell or otherwise dispose of any or all of such obligations in any manner and on such terms as the Board of Directors may deem proper.

The corporation shall have the power to purchase, receive, redeem, or otherwise acquire, own, hold, sell, mortgage, pledge, or otherwise acquire or dispose of and otherwise use and deal in and with its own shares of stock.

VIII.

The corporation shall indemnify any and all persons who may serve or who have served at any time as directors or officers, or who at the request of the Board of Directors of the corporation may serve or at any time have served as directors or officers of another corporation in which the corporation at such time owned or may own shares of stock or of which it was or may be a creditor, and their respective heirs, administrators, successors, and assigns, against any and all expenses, including amounts paid upon judgments, counsel fees, and amounts paid in settlement (before or after suit is commenced), actually and necessarily incurred by such persons in connection with the defense or settlement of any claim, action, suit, or proceeding in which they, or any of them, are made parties, or a party, or which may be asserted against them or any of them, by reason of being or having been directors or officers or a director or officer of the corporation, or of such other corporation, except in relation to matters as to which any such director or officer or former director or officer or person shall be adjudged in any action, suit, or proceeding to be liable for his own negligence or

misconduct in the performance of his duty, such indemnification shall be in addition to any other rights to which those indemnified may be entitled under any law, bylaw, agreement, vote of stockholders, or otherwise.

IX.

In addition to the powers and authority granted to the directors in the Articles of Incorporation and in addition to the powers and authority expressly conferred upon them by statute, the Board of Directors of the corporation shall have additional powers and authority not inconsistent with the laws as may be set forth in the By-Laws.

X.


