ARTICLES OF INCORPORATION

OF

The undersigned, acting as the incorporator of a corporation, hereby adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is HENDERSON,

SECOND: The period of the corporation's duration is perpetual.
