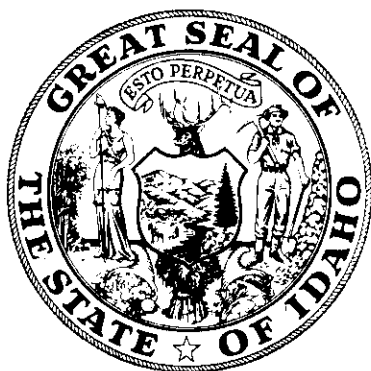

ARTICLES OF INCORPORATION

WE, the undersigned, being natural persons of full age, and citizens of the United States of America, and being all the shareholders, officers and directors of JD, INCORPORATED, do hereby amend the Amended Articles of Incorporation as follows: the purpose of forming this corporation is to do business within and without the State of Idaho for a profit. With the exception of this item, each and every article of the original Amended Articles of Incorporation remain the same.

ARTICLE I

NAME

The name of the corporation shall be JD, INCORPORATED.

ARTICLE II

PURPOSES

The purposes of the corporation are:

(1) To buy, sell, lease, receive, invest in and in any other way acquire, import, lease, maintain, own or hold for investment or otherwise use real property and personal property and with property of every kind and character, tangible or intangible.

(2) To design, develop, invest, repair, alter, assemble, construct, operate, manufacture and all other ways within and with property of every kind and character.

(3) To hire and employ agents, servants and employees, and to enter into agreements of employment and collective bargaining agreements, and to act as agent, contractor, trustee, factor or otherwise, either alone or in company with others.

(4) To promote or aid in any manner, financially or otherwise, any persons, firm, association or corporation, and to guarantee contracts and other obligations.

(5) To let concessions to others to do any of the things that this corporation is empowered to do, and to enter into, make, perform and carry out, contracts, arrangements of every kind and character with any person, firm, association or corporation, or any government or authority or subdivision or agency thereof.

(6) To carry on any business whatsoever, that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated directly or indirectly, to improve the interests of this Corporation and to do all things and to exercise all powers conferred by the laws of the State of Idaho on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations

or corporations, and in any part of the world.

(7) Specific purpose is that of Construction and land development.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers shall be liberally construed in aid of the powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in no ways limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purpose, but the purposes and powers stated shall be construed liberally as each object expresses, and the enumeration as to specific powers shall not be construed as to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of said general powers.

ARTICLE III

DURATION

The duration of this corporation is perpetual.

ARTICLE IV

ARTICLE V

STOCK

The total authorized number of par value shares of stock is not more than 5,000. The aggregate par value of the total authorized number of par value shares is FIVE THOUSAND (\$5,000.00) DOLLARS. The total authorized number of shares without par value is none.

The stock of the corporation is divided in 5,000 shares of common stock, at a par value of ONE (\$1.00) DOLLAR per share. The shares of stock of the corporation shall not be subject to assessment. There shall be only one class of shares each of which shall have equal voting power.
