ARTICLES OF INCORPORATION

of

RICKS & CAMPBELL, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, being bona fide residents of the State of Idaho, do hereby associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

That the name of this corporation shall be

RICKS & CAMPBELL, INC.

Π.

The purposes for which this corporation is formed are as follows:

- A. To engage in, and to deal in, to buy, purchase, sell, trade, and otherwise handle masonary supplies, cinder block, block, brick, stone, tile and related supplies and equipment of all kind; to store and warehouse the same, and to distribute both at wholesale and retail said items.
- B. To carry on a general business of masonary contracting in all of its branches; to purchase, lease and otherwise acquire the necessary goods, wares, merchandise, apparatus, machinery and supplies for the conduct of said business.
- C. To engage in, and to deal in, to buy, purchase, sell, trade and otherwise handle painting supplies, brushes, paint, equipment and related supplies of all kinds; to store and warehouse the same and to distribute, both at wholesale and retail, said items.
- D. To carry on a general painting contracting business in all of its branches; to purchase, lease and otherwise acquire the necessary goods, wares, merchandise, apparatus, machinery and supplies for the conduct of said business.
- E. To carry on, in all its branches thereof, the business usually carried on by stone and brick masons, tile layers and stone masons; to make and perform contracts for the erection, construction, alteration and repair of all and any kind of buildings composed in whole or in part of the above described brick, tile, or stone.
- F. To carry on in all its branches thereof, the business usually carried on by painting contractors; to make and perform contracts for the painting, repair and decorating of all and any kind of buildings or structures.
- G. To purchase, hold and use, from time to time as it may see fit, any shares of its own stock, using for such purpose any part of its surplus, but while this corporation holds the same, it shall not be entitled to vote such stock or receive dividends there on.
- $\ensuremath{\mathrm{H_{\bullet}}}$ To purchase, hold, acquire and sell stock in any other corporation or corporations.

- I. To acquire, hold, sell and dispose of all necessary property, both real and personal, to carry out the objectives herein stated.
- J. To borrow money and execute notes and mortgages therefor, and to lend money and take notes and mortgages to secure the repayment of the same; to acquire real estate and personal property for investment purposes and to manage, rent, control, repair and otherwise deal in real estate and personal property.
- K. To do all things incident to or connected with any of the aforementioned purposes, which might further and aid the purposes and objectives as aforesaid.

That the period of existence of this corporation shall be perpetual.

The location and postoffice address and the registered office of this corporation shall be Pocatello, Bannock County, Idaho.

The business and prudential affairs of this corporation shall be managed by a board of three (3) directors, all of whom shall be stockholders of said corporation.
