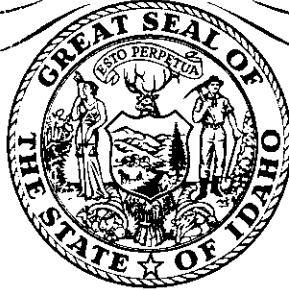

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

#### THE FIFTY-FIRST CORPORATION, INC.

was filed in the office of the Secretary of State on the **Third** day of **April**, A. D. One Thousand Nine Hundred **Sixty-two** and is duly recorded on Film No. **119** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Boise** in the County of **Ada** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
of  
THE FIFTY-FIRST CORPORATION, INC.

We, the **undersigned** natural persons of the age of twenty-one years or more, and all being citizens and bona fide residents of the State of Idaho, acting as incorporators of a corporation formed under and pursuant to the provisions of Chapter 39 of the Idaho Code, adopt the following articles of incorporation for such corporation:

1.

The name of the corporation is

THE FIFTY-FIRST CORPORATION, INC.

2.

The corporation is to have perpetual existence.

3.

The purposes for which the corporation is organized are:

To engage in the business of conducting, operating and maintaining an institution or institutions of learning for the instruction of students in the theoretic and practical branches of scientific, technological, business, industrial and commercial fields, as well as in related and allied or kindred fields of the liberal and literary arts, and to exercise all of the rights and privileges now or hereafter to be conferred on such educational institutions by the laws of Idaho and the general customs and practices of such institutions.

The corporation shall have no capital stock and shall not be conducted for pecuniary profit. No distribution of the property of the corporation among the members of the corporation shall be made. All of the property of the corporation shall be devoted to the purposes hereinbefore specified. The rights and interests of all members shall be equal.

4.

The place where the institution is to be located is Caldwell, Idaho, and such other places as the board of trustees may from time to time deter-

mine. The address of the initial office of the corporation is Box No. 2353, Boise, Idaho.

5.

The number of trustees constituting the initial board of trustees is five, and the names and addresses of the persons who are to serve as initial trustees are:

The number of members of the board of trustees may be increased or decreased from time to time to any number not less than five nor more than thirty in accordance with the provisions of the by-laws.

7.

The board of trustees shall have and exercise all of the rights and powers provided for by Section 33-3908, Idaho Code, as now or as may hereafter be constituted, and shall have and may exercise all other rights and powers now or hereafter provided by applicable laws of the State of Idaho. The provisions for the regulation of the internal affairs of the corporation shall be fixed by the by-laws of the corporation.


