ARTICLES OF INCORPORATION
OF
EASTERN IDAHO SPECIAL SERVICES AGENCY, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being of legal age and being citizens of the United States of America and residents of the State of Idaho, do hereby, as incorporators hereof, form a non-profit cooperative association for charitable purposes under the laws of the State of Idaho, according to and in compliance with Title 30, Chapter 10, Idaho Code, and do hereby adopt Articles of Incorporation as follows:

ARTICLE I.

Name

The name of this corporation shall be EASTERN IDAHO SPECIAL SERVICES AGENCY, INC.

ARTICLE II.

Purposes

The purposes for which this corporation is formed are as follows:

1. To work to eliminate the causes of social problems.
2. To develop and administer social service programs which will serve the needs and promote the general welfare of all underprivileged, aged and other persons in need of special social services.
3. To serve all who have need for and are otherwise eligible to receive its services without discriminating against any person by reason of race, creed, religion or national origin.
4. To receive monies, equipment or labor from any source, whether private, city, county, state, federal, or whatever, or purchase, convey, mortgage, and lease all kinds of real and personal property or otherwise use funds for the accomplishment of the purposes stated herein.
5. To borrow money and to draw, make, accept, endorse, assign, guarantee, execute and issue notes, checks, drafts, bonds, debentures, negotiable instruments and other instruments for the payment of money and to mortgage or pledge its property to secure such obligations.

6. To have, exercise and enjoy all powers now or hereafter granted to corporations organized under the laws of the State of Idaho, and particularly all the powers and privileges granted to corporations under Title 30, Chapter 10, Idaho Code, and in present and future amendments thereto, and to engage in any other activity and to do any act or other thing necessary to carry into effect the aforementioned purposes.

7. To exercise and perform all of the above described powers both within and without the State of Idaho.

ARTICLE III.

Principal Place of Business

The location and post office address of the registered office of said corporation shall be the City of Idaho Falls, County of Bonneville, State of Idaho.

ARTICLE IV.

Duration

The duration of this corporation shall be perpetual.

ARTICLE V.

Members

This corporation is organized without capital stock, and the rights and interests of all its members shall be equal. The qualifications for membership shall be as provided in the Bylaws.

ARTICLE VI.

ARTICLE VIII.

Dissolution

Upon dissolution of this corporation by operation of law or otherwise, all assets of the corporation shall be distributed to a government body or a nonprofit corporation or corporations with like objectives and with tax-exempt status under Section 501 (c) (3) of the Internal Revenue Code as is presently enacted.
