ARTICLES OF INCORPORATION SECRETARY OF STATE

OF

NAC BAIL BONDS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is NAC BAIL BONDS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 4,000. at \$1.00 par value.

FIFTH: Provisions denying preemptive rights are: no preemptive rights are to be denied the shareholders.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: that said internal affairs are to be in compliance with the laws of the State of Idaho.
