



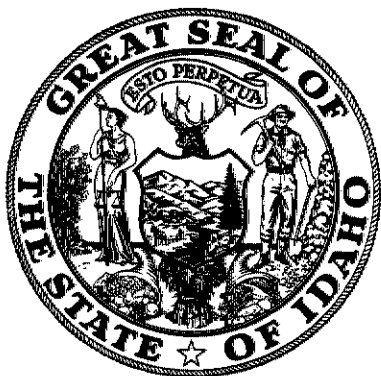
**CERTIFICATE OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation.

FIRST: The name of the corporation is Advanced Electrical Systems Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized are the transaction of any or alllawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
