AMENDED ARTICLES OF INCORPORATION

OF

RONALD MCDONALD CHILDREN'S CHARITIES OF SOUTHEAST IDAHO, INC.

A Nonprofit Corporation

Pursuant to Sections 30-1-59 through 30-1-62 of the Business Corporation Act of the State of Idaho, the above named Corporation adopts the following Amended Articles of Incorporation to its original Articles of Incorporation:

I

In compliance with Section 30-1-59, Idaho Code, the undersigned, being the Incorporator of the aforementioned Corporation, has adopted a resolution setting forth the proposed amendment to the original Articles of Incorporation.

ΙI

The Articles of Incorporation are hereby amended as follows:

ARTICLE III PURPOSES

Lines sixteen (16) and seventeen (17) stating that "The Corporation is a private foundation as defined in Section 509 of the Internal Revenue Code" shall be omitted from the Articles of Incorporation.

Except for the above designated amendment, these Amended Articles of Incorporation adopt the corresponding provisions of the original Articles of Incorporation without change. These Amended Articles of Incorporation, with the above designated amendment, supersede the original Articles of Incorporation.
