RE: Use of the Word "Bank" in Company Name in Idaho

Dear Ms. Stronk:

The Idaho Department of Finance (Department) received your email on November 17, 2015, requesting approval by the Department as to the use of the word "bank" in Idaho by your client, Zions First National Bank, a federally chartered financial institution. As you indicated in your email, your client is seeking to do business in Idaho as "Zions Bank."

Idaho Code § 26-1202 generally prohibits persons from advertising or transacting business in this state under a name or title containing the word "bank," "banker," or a word or words of similar import, unless the person holds a banking charter. However, Idaho Code § 26-1202(2) states that the "prohibition shall not apply to a national bank...." Since the statute does not apply to a national bank, there is no need for the Director of the Department to grant a waiver to a federally chartered financial institution to use the word "bank" in its name in Idaho and the Director likely would not be authorized to use the waiver process. Under these circumstances, the Department certainly does not have any objection to the use of the proposed name.
