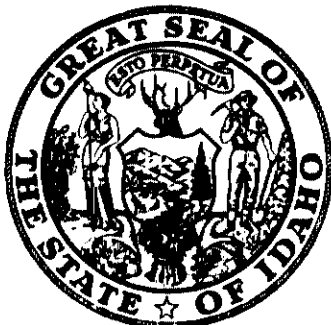

ARTICLES OF INCORPORATION

OF

GSA CANYON, INC.

4 The undersigned, acting as incorporators of GSA Canyon, Inc., a corporation
5 under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for
6 such corporation:
7

8 FIRST: The name of the corporation is GSA Canyon, Inc.

9 SECOND: The period of its duration is perpetual.

10 THIRD: The purpose or purposes for which the corporation is organized are:

11 (A) To conduct business as a general contractor and to provide design/building
12 services with respect to buildings, development and subdivision in the broad sense including,
13 but not limited to, property management and design work.

14 (B) To carry on any other kind of business or business activities that the Board
15 of Directors may from time to time deem to be advisable or proper in connection with the
16 business.

18 (C) To purchase, lease, own, sell, mortgage, sublease, and otherwise acquire
19 lands, buildings, easements of property, real and personal, which may be requisite for the
20 purposes or are capable of being conveniently used in connection with any of the objects of this
21 corporation, and to enter into, make, perform and carry out contracts of every sort and kind
22 with any person, and to acquire and take over the good will, property, rights, franchises and
23 assets of every kind and the liabilities of any person, firm, association, or corporation, either
24 wholly or in part, and to pay for the same in cash, stocks or bonds of the corporation, or
