The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following articles of incorporation:

I.

The name of the Corporation is: Lloyd's Carpet Service, Inc.

II.

The Corporation is to have perpetual existence.

III.

The Corporation is organized for the purpose of Carpet Installation and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
