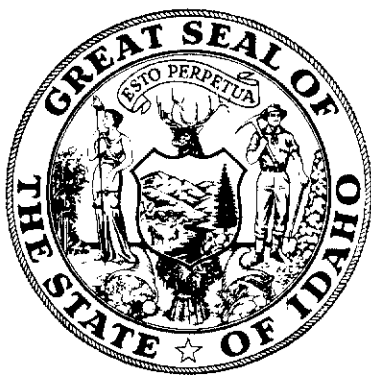

The undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Orthopedic Technology, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on MARCH 31, 1987, in the manner prescribed by Idaho law:

The name of the corporation is hereby changed to VH, Inc.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was ninety-six (96); and the number of shares entitled to vote thereon was ninety-six (96).

FOURTH: The number of shares voted for such amendment was ninety-six (96); and the number of shares voted against such amendment was zero (0).
