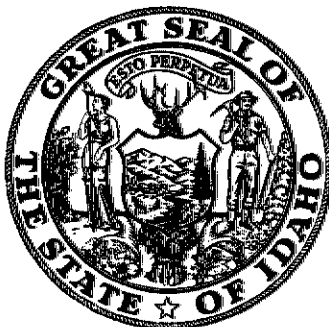

KNOW ALL MEN BY THESE PRESENTS, That Dr. Troy Norris, the undersigned, in order to form a corporation for the purposes hereinafter stated, pursuant to the Professional Service Corporation Act of the State of Idaho, as now in effect or as may hereafter be amended, does hereby certify as follows:

ARTICLE I

The name of the corporation is Norris Chiropractic Clinic, Inc. P.A.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

This corporation is organized for the purpose of engaging in the practice of chiropractic care and of transacting all lawful business which this corporation may do under the Professional Service Corporation Act of the State of Idaho.

The name and address of the incorporator and organizer who has named himself as the initial director to serve until the first election of the directors of the corporation is as follows:


