- ì. Name. The name of the Corporation is "Portneuf Health Care Foundation, Inc."
- 2. Amendments. The Restated Articles are amended as follows:
 - A. Article 1, NAME, is amended to read as follows:
 - 1. NAME: The name of the Corporation is "Portneuf Health Trust, Inc."
 - В. Article 8, REGISTERED AGENT AND OFFICE, is amended to read as follows:
 - 8. REGISTERED AGENT AND OFFICE: The current registered agent is Shaun Menchaca and the current registered office is 500 South 11th Avenue. Suite 503, Pocatello, Idaho 83201.
- Remainder of Restated Articles. The provisions of the Restated Articles not amended hereby shall remain in full force and effect until amended in accordance with the provisions thereof.
