**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
REINCO, INC.**

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is REINCO, INC.

SECOND: The following amendments to the Articles of Incorporation were adopted by all the shareholders and directors of the corporation on the 20th day of March, 2002, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE I of the Articles of Incorporation is revoked and the following new ARTICLE I shall take its place:

“The name of the corporation is **ProWest, Inc.**”

ARTICLE V of the Articles of Incorporation is revoked and the following new ARTICLE V shall take its place:

“The address of the initial registered office of the corporation is 15635 Riverside Road, Caldwell, Idaho 83605, and the name of its initial registered agent at such address is William L. Downing.”

THIRD: The number of shares of the corporation not issued at the time of such adoption was 100; and the number of shares issued, outstanding, and entitled to vote thereof is 100.

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:


