Be it known that we the undersigned have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho and do hereby make and subscribe the following Articles of Incorporation.

The name of said Corporation is Latour Lumber Company Limited

The purposes for which said Corporation is formed are; to carry on tim ousiness of manufacturing lumber, ties, somes and shingles and all other products of timber, to construct, buy and own a sawmili or sawmills for the manufacture of lumber and all other products of timber; to acquire, our and own any real property necessary for the said sawmills and for lumberyards and storehouses and for any purposes necessary or useful in connection with said business; and to buy, acquire and own timper and timber lands and all kinds of personal property necessary or useful in connection with tre manufacture of timber products; and to deal in such real and personal property; to buy timber and lumber, and to sell lumber and all products of timber at wholesale and retail; to buy, acquire, construct, maintain and operate any railroad and telegraph and telephone lines necessary or useful in connection with said pusiness of manufacturing, buying and selling timber and lumber and all other timber products; to acquire, buy, own, construct and operate any other road or roads, tranways or flumes; and to buy, acquire, own and operate pooms, soats and any other property useful or servicable in connection with the operation of said ousiness.

The place where the principal business of said corporation is to be transacted shall be at <u>Cataldo</u> County of <u>Kootenai</u>.
