AMENDMENT TO CERTIFICATE AND STATEMENT IN RESPECT TO RESOLUTION ESTABLISHING AND DESIGNATING CUMULATIVE PREFERRED STOCK, \$2.40 CONVERTIBLE SERIES OF 1970, AND FIXING AND DETERMINING THE MAXIMUM NUMBER OF SHARES TO BE ISSUABLE AND OUTSTANDING

KNOW ALL MEN BY THESE PRESENTS, that ROBERT E. YANCEY, as President, and JOHN P. WARD, as Secretary, of ASHLAND OIL, INC., a Kentucky corporation (herein called the "Company"), do hereby certify that at a meeting of the Board of Directors of the Company duly called and held in accordance with law and the By-laws of the Company on January 24, 1979, the following resolution amending the original resolution, as amended, establishing and designating the \$2.40 Convertible Series of 1970 of the Cumulative Preferred Stock of the Company was duly adopted to reflect a decrease in the number of shares of such series which shall hereafter be issuable and outstanding:

RESOLVED, that, pursuant to the authority expressly vested in the Board of Directors by the Company's Restated Articles of Incorporation, and pursuant to the right reserved in the resolution adopted by the Board of Directors of the Company on August 3, 1970, as amended by such Board of Directors on July 21, 1971, establishing and designating the \$2.40 Convertible Series of 1970 of the Cumulative Preferred Stock of the Company, Section I of that resolution be, and it hereby is, further amended to read in full as follows:

I. Designation of Series and Maximum Number of Shares to be Issuable and Outstanding. This series of the Cumulative Preferred Stock shall be designated "Cumulative Preferred Stock, \$2.40 Convertible Series of 1970" (herein called the "\$2.40 Series of 1970"), of which not more than 515,000 shares shall hereafter be issuable and outstanding at any one time.
