## ARTICLES OF INCORPORATION

OF

## DARROW FARMS, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned being natural persons over the age of eighteen (18) years, do hereby form a general business corporation under the laws of the State of Idaho as contained in Title 30 of the Idaho Code entitled "General Business Corporations Act", and to that end do hereby set forth:

- The name of the corporation is: DARROW FARMS, INC.
- 2. The period of duration of this corporation shall be perpetual.
- 3. The purposes for which this corporation is organized are:
- (a) To purchase, own, improve, equip, operate and manage farms and engage in any agricultural pursuit or undertaking.
- (b) To engage in a general livestock dairy, and ranching business, both on its own account and as agent; to agist, feed, range, graze, manage, herd, control, brand, care for, purchase, market, and sell livestock of every kind, both on its own account and as agent for other persons or corporations, buy, lease, cultivate, manage, operate, sell ranch properties and products therefrom on both its own account and as agent for other persons or corporations.
- (c) The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.
- 4. The county in the State of Idaho where the principal office for the transaction of business of the corporation is

located is in the County of Twin Falls and the name of the registered agent is Robert C. Weaver and the address of the registered office shall be 130 North Broadway, Buhl, Idaho 83316.

- The amount of the authorized stock of said corporation shall be \$100,000 divided into 1,000 shares of common stock of the par value of \$100.00 per share.
- 6. The names and post office address of each of the incorporators is as follows:

- The directors of the corporation shall have the power to sell any authorized but unissued stock at any time and to any person, and no stockholder shall be entitled, as of right to subscribe for or purchase of any of such additional shares of stock.
- The number of directors of the corporation may be fixed by the By-Laws, but shall not be less than the number required by law.

The number of directors consituting the intial Board of Directors shall be four (4), and they shall serve as directors until their successors are elected and qualified.
