The undersigned, acting as the incorporator of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following Articles of Incorporation for the Corporation.

**ARTICLE I – NAME**

The name of the Corporation is Southeast Idaho Judo, Inc.

**ARTICLE II – NONPROFIT STATUS**

The Corporation is a nonprofit corporation.

**ARTICLE III – PERIOD OF DURATION**

The period of duration of the Corporation is perpetual.

**ARTICLE IV – INITIAL REGISTRATION OFFICE AND AGENT**

The location of this Corporation is in the City of Pocatello, County of Bannock, State of Idaho. The address of the initial registered office is 5165 Mohawk Avenue, Pocatello, Idaho 83204, and the name of the initial registered agent is Sami Tadehara.

**ARTICLE V – PURPOSES**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE VI – LIMITATIONS**

No part of the net earnings or assets of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted by the Internal Revenue Code or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation

## **ARTICLE VII – MEMBERS**

The Corporation shall have no voting members. All management authority shall be vested in the Board of Directors.

## **ARTICLE VIII – BOARD OF DIRECTORS**

The affairs of the Corporation shall be managed by its Board of Directors. The Board of Directors shall consist of not less than three (3) nor more than twenty (20) individuals. The actual number of Directors shall be fixed by the Bylaws of the Corporation. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected or appointed by the existing Directors in the manner and for the term provided in the Bylaws of the Corporation.

## **ARTICLE IX – DISTRIBUTION ON DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

## ARTICLE X – INCORPORATOR

The name and street address of the incorporator is Sami Tadehara, 5165 Mohawk Avenue, Pocatello, Idaho 83204.

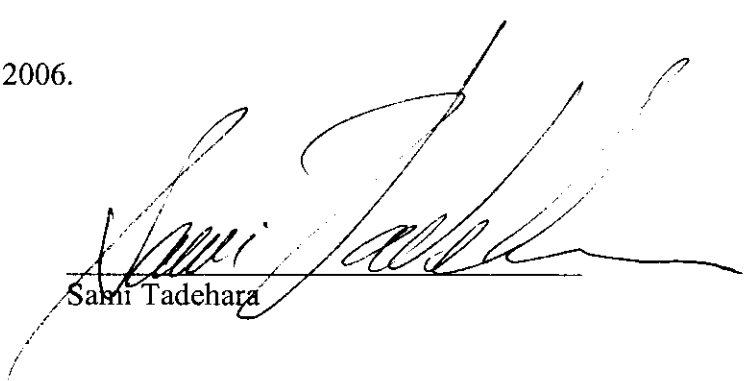
## ARTICLE XI – BYLAWS

## ARTICLE XII – AMENDMENTS

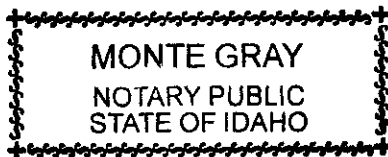

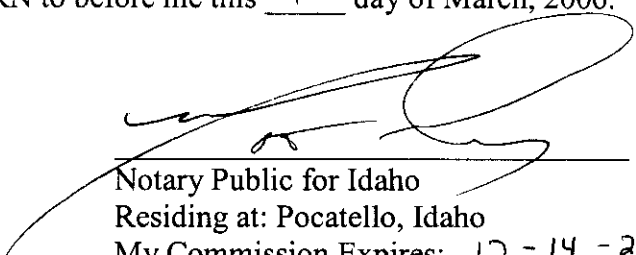
