SUBJECT: To amend the ARTICLES OF INCORPORATION.

On October 9, 1987 the Board of Directors voted unanimously to amend the articles by adding to Article II the following.

"Upon the winding up and dissolution of the corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaning assets shall be distributed to a nonprofit fund, foundation, or corporation which is observed and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501 (c) (3) of the Internal Revenue Code."

"This organization is organized exclusively for charicalle purposes within the marin of section 501 (a) (3) of the Internal Revenue Code."

"Notwithstandin any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by an organization contributions to which are deductible under section 170 (c) (2) of the Internal Renenue Code of 1954 (or the corresponding provision of any future United States Internal Renenue Law." This amendment was voted on Cotober 9,1987 and is to take effect as of that date.

The Board of Directors are the only people who are members at this time.
