That we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a non-profit cooperative association as a corporation, for the purposes hereinafter stated, pursuant to Chapter 10, Title 30 of the Idaho Code, do hereby certify as follows:

#### ARTICLE I

The name of the corporation is and shall be the CANYON COUNTY DEPUTY SHERIFF'S ASSOCIATION, INC.

#### ARTICLE II

The purposes for which said corporation is organized and incorporated are and shall be:

- 1. To secure closer official and personal relationship among the members, all of whom will be deputies to the Sheriff of Canyon County.
- 2. To secure by all proper and legal method, legislation and governmental action for the general and official welfare of the members of this corporation, as related to law enforcement.
- 3. To advance and professionalism the standard of law enforcement work by the members and to secure the recognition of said advancement and professionalization by the general public.
- 4. To promote legislation pertaining to the detection and prevention of crime, and to the insurance of law enforcement efficiency in general.
- 5. - 7. To purchase, lease, acquire, accept, hold and manage by deed, grant, will, gift, bequest, trust, or otherwise, all manner and kinds of property, whether real, personal or mixed, to be used for, and to carry out the purposes for which this corporation is organized.
- 8. To borrow, sell, mortgage, issue its notes, bonds, debentures and other evidences of indebtedness and to do any and every act or thing germane to the aforesaid purposes.
- 9. This shall be a non-profit, non-stock, cooperative association corporation.

#### ARTICLE III
