ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are of adult age and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho, and we do hereby certify:

Ι.

The name of the corporation shall be BLACKFOOT BOARD OF REALTORS, INC.

II.

The purposes for which this corporation is formed are:

- 1. To unite those engaged in the recognized branches of the real estate business in this community for the purpose of exerting a beneficial influence upon matters affecting the real estate business and related interests.
- 2. To provide a unified medium for real estate owners and those engaged in the real estate business whereby their collective and individual interests may be safeguarded and advanced.
- 3. To promote and maintain the high standards of conduct in the transacting of the real estate business as expressed in the Code of Ethics of the National Association of Real Estate Boards, and to provide the organization whereby the ethics of individual members might be examined for the benefit of all the members of this organization and for the community in general.
- 4. To further the interest of real estate, and home and other real property ownership.

shall issue membership certificates to each member thereof. These certificates of membership cannot be assigned to permit the transferee thereof, by such transfer, to become a member of the association except by resolution of the Board of Directors and under such regulations as the By-Laws of this corporation may prescribe. The rights and interests of all members of this association shall be equal and no member shall have or acquire a greater interest than any other member. The Board of Directors is hereby empowered to authorize the issuance of membership certificates from time to time within the limits authorized by these articles and the By-Laws.

No alien may serve as an officer or member of the Board of Directors of this corporation. The number of directors of said corporation shall be not less than (3) three nor more than (7) seven to be elected annually.
