ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF FLOJODO MINES, INC.

Pursuant to the provisions of the Idaho Business

Corporation act, the undersigned corporation adopts the

following Articles of Amendment to its Articles of Incorporation:

FIRST: The present name of the corporation is FLOJODO MINES, INC.

SECOND: The following amendments to the Articles of Incorporation were adopted by the shareholders of the corporation on the 22nd day of May, 1984, in a manner prescribed by the Idaho Business Corporations Act:

That Article V of the Articles of Incorporation be amended to read as follows:

This company shall be capitalized for \$1,000,000.00. The total authorized stock of this corporation shall be divided into ten million shares, all of which shall be common stock with a par value of \$0.10 per share. Said shares shall be nonassessable and shall all be of the same class and every share of said stock shall be equal in all respects to every other share.

The said shares may be issued and sold from time to time by the corporation for such consideration and upon such terms as may, from time to time, be fixed by the Board of Directors without action by the stockholders.

The Board of Directors of this corporation shall have the power and authority from time to time to authorize the sale of, and to sell for cash or otherwise, all or any portion of the unissued stock or the treasury stock of this corporation without said stock, or any portion thereof, being first offered to the shareholders of this corporation. This corporation shall have the power and may at any time reacquire the whole or any part of its common stock by paying therefore the market value as may be

determined from time to time when such right is exercised.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 4,428,016, and the number of shares entitled to vote thereof was 4,428,016. The number of shares voted for the amendment to the Article V of the Articles of Incorporation was 2,831,516 and the number of shares voted against amendment was zero.

The manner in which such amendment affects a FOURTH: change in the amount of stated capital is as follows: Previous stated capital: \$500,000.00, stated capital as changed by such amendment: \$1,000,000.00.
