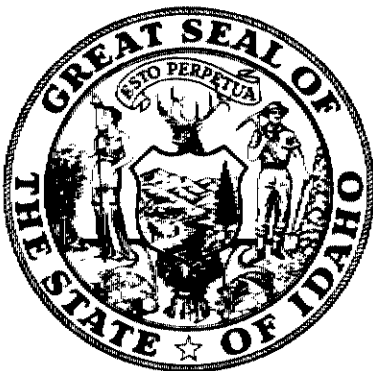

ARTICLES OF INCORPORATION

OF


1. The name of the corporation is ZETA PI HOUSE CORPORATION OF KAPPA KAPPA GAMMA FRATERNITY.
2. The corporation is nonprofit and shall not have or issue shares of stock or pay dividends.
3. The period of duration is perpetual.
4. The purposes of the corporation are as follows:
 - (a) This corporation is organized and operated exclusively as a Social and Recreation Club within the meaning of Section 501 (c)(7) of the Internal Revenue Code; and to engage in any lawful act or activity under Title 30, Chapter 3, Idaho Code of the Idaho Nonprofit Corporation Act.
 - (b) The corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers not permitted to be carried on by a corporation exempt from federal income taxes under Section 501(c)(7) of the Internal Revenue Code.
 - (c) To lease or own and maintain real and personal property to further the educational, cultural, ethical, and social needs of its members.
5. The classes, rights, privileges, qualifications, obligations, and the manner of election or appointment of members are as follows:
 - (a) There shall be only one class of members, and each member shall have equal rights and privileges and one vote on each action submitted.
 - (b) Each member of ZETA PI Chapter of The College of Idaho and any alumna of KAPPA KAPPA GAMMA FRATERNITY in good standing may be a member of this corporation pursuant to the bylaws upon completion of the payment of the membership fee (House Association Fee).
 - (c) A member of this Corporation shall be under no obligation to the corporation or its creditors with respect to such membership.
 - (d) The property and business of the corporation shall be controlled and its powers and authorities shall be vested in and exercised by the Board of Directors (Trustees) which are elected by the members pursuant to the bylaws of the corporation.

6. Other provisions: No part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer of member thereof, or any private person. Upon the dissolution or winding up, its assets remaining after payment of all debts and liabilities shall be distributed to a nonprofit fund, foundation or corporation.
7. The initial registered office is 4017 EDMONT RD., BOISE, IDAHO 83706 and the initial registered agent is KERRIE MURRAY.
