ARTICLES OF AMENDMENT

OF

ARTICLES OF INCORPORATION **

Gregory Baumgast does hereby certify and declar that he is the President and Secretary of GREGORY DESIGN CONSTRUCTION COMPANY, INC., an Idaho corporation organized and existing under and by virtue of the laws of the State of Idaho. By agreement of the sole stockholder in lieu of special meeting of the stockholder of Gregory Design & Construction Company, Inc., the Articles of Incorporation of Gregory Design & Construction Company, Inc., were amended to change the name of the corporation from "Gregory Design & Construction Company, Inc." to "BAUMGART CONSTRUCTION, INC." and by amending Article I of the Articles of Incorporation to read as follows:

ARTICLE I

The name of this corporation is "BAUMGART CONSTRUCTION, INC."

It was further agreed by the sole stockholder in lieu of a special meeting of the stockholder of Gregory Design & Construction Company, Inc., that the Articles of Incorporation be further amended to show the new address of the corporation by amending Article III to the Articles of the Incorporation to read as follows:

ARTICLE III

The registered office of this corporation in the State of Idaho shall be located in the County of Ada, State of Idaho, and the post office address of such registered office shall be 2417 Bogus Basin Road, Boise, Idaho 83702.

The sole stockholder of the corporation executed the agreement in lieu of a meeting and adopted the above amendments on the limit day of the lieu, 1980.

By such agreement in lieu of meeting, the undersigned President and Secretary were further instructed to cause Articles of Amendment to be prepared, sworn to and filed as required by law to accomplish the amendments of the Articles in accordance with the agreement of the Stockholder.

There are 2,500 shares outstanding and entitled to vote and all shares were voted by the sole Stockholder of this Corporation in favor of the amendments.
