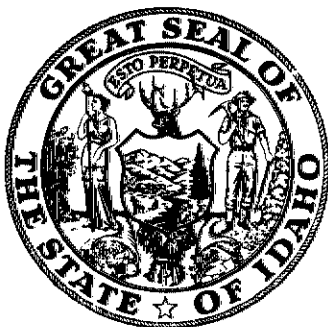

WHEREAS, SCOTT'S MARKET EQUIPMENT, INC., was organized under and by virtue of the laws of the State of Idaho on the 3rd day of January, 1994, and

WHEREAS, said Articles of Incorporation were duly and regularly filed in the Office of the Secretary of State, State of Idaho, on the 5th day of January, 1994, and

WHEREAS, on the 23rd day of September, 1994, Article IX, Section 1 of the Articles of Incorporation of said corporation was amended to change the minimum number of directors from three (3) to two (2).

NOW, THEREFORE, we the undersigned, W. C. Scott and Sandra Romans, President and Secretary, respectively of SCOTT'S MARKET EQUIPMENT, INC., a corporation organized and existing under and by virtue of the laws of the State of Idaho, do hereby certify as follows:

That the said W. C. Scott is President of the said corporation, and the said Sandra Romans is Secretary of said corporation.

That at a special meeting of the stockholder of said corporation held on September 23, 1994, at which W. C. Scott was present, together with Patricia K. Scott and Sandra Romans by invitation, the stockholder passed and adopted a resolution amending the Articles of Incorporation of said corporation which resolution is as follows:

That the Articles of Incorporation be, and they are hereby amended by striking therefrom Article IX, Section 1 and adding thereto the following new Article IX, Section 1 so that the Articles of Incorporation, as amended, shall read as follows:

Article IX, Section 1. Size of Board. The number of Directors shall be as specified in the by-Laws of the corporation and such number may from time to time be increased or decreased in such manner as prescribed by the By-Laws. In no event shall the number of Directors be less than two (2). Directors need not be Stockholders."

We do further certify that the following is a true and correct copy of said Articles of Amendment of Scott's Market Equipment, Inc., a corporation, to-wit:

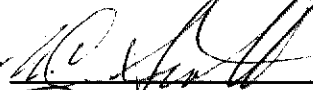

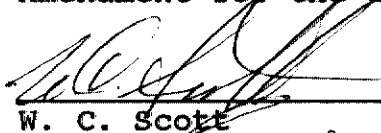
