

KNOW ALL MEN BY THESE PRESENTS:

That wc, GERALD A. E. RIBA and PAUL DENNIS RIBA, being desirous of forming a corporation for the purposes hereinafter specified and in conformity with and by virtue of the laws of the State of Washington, do make, subscribe and execute in triplicate originals the following Articles of Incorporation:

I.

The name of this corporation shall be RIBA BROS., INC.

II.

The purposes for which this corporation is organized shall be:

1. To establish, maintain, conduct, and operate food markets, grocery stores, bakeries, and stores of every kind, nature and description; to purchase, buy, sell, exchange, grow, produce, manufacture, process, market, export, import, handle, store, distribute, and otherwise generally deal in any and all articles of food, food products, household products, groceries, dairy products, wines, liquors, beverages of all kind, meat and meat products, vegetables and vegetable products, provisions, produce, poultry, fish, game, and food supplies of all kinds, both at wholesale and retail, and acquire, construct, maintain, operate, buy, sell and deal in stores selling such goods, wares, and merchandise; to acquire, construct, establish, maintain, operate, or sell or dispose of, factories, plants, warehouses, dairy plants, creameries, machinery and equipment, markets, stores, depots, and gathering and delivery routes and systems, for such purposes.

- 2. To have and exercise all the powers conferred by the laws of the State of Washington.
- 3. In general, to do any and all things necessary, suitable or proper for accomplishment of any of the purposes or for the attainment of any of the objects or for the exercise of any of the powers herein set forth, whether herein specified or not, and to do any and all other acts and things incidental or pertinent to or connected with the purposes of this corporation.

III.

The time of existence of this corporation shall be perpetual.

IV.

The location of the principal place of business of this corporation shall be 116 West First Street, Cheney, Washington, and GERALD A. E. RIBA, located at that address, is its initial, registered agent.

٧.

The capital of the corporation shall be Fifty Thousand Dollars (\$50,000.00) divided into 50,000 shares of common stock with a par value of One Dollar (\$1.00) per share.

VI.

The corporation will not commence business until consideration of the value of at least Five Hundred Dollars (\$500.00) has been received for the issuance of shares.

VII.
