ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are bona fide, natural born citizens of the United States of America do, under and in pursuance of the general corporation laws of the State of Idaho, hereby organize, constitute and associate ourselves, and such other persons as may hereafter become associated with us, into a body politic and corporation, and to that and execute the following ARTICLES OF INCORPORATION, and we hereby set forth and declare as follows:

I

That the name of this corporation is, and shall be, WALKER'S CAFE, INC.

That the period of the existence of this corporation shall be perpetual.

That the principal office of this corporation shall be located at Rigby, Jefferson County, Idaho, and that other offices for the transaction of the business of said corporation shall be established by the Board of Directors from time to time, both within and outside of the State of Idaho, and that the meetings of the Board of Directors may be had pursuant to the provisions of the By-laws either at the principal office or at such other places as By-laws shall provide.

I۷

The purposes for which this corporation is formed are as follows:

- a. To engage in a general cafe business catering to the public and private groups in providing all kinds of food and drink for their consumption.
- b. To conduct and carry on the business of growing marketing and harvesting of all kinds of foodstuffs, together with any feeds for all livestock or other animals and fowl.
- c. To engage in the wholesale purchase and sale of food and supplies, furniture and equipment.

- d. To purchase, or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage or otherwise dispose of, and to invest, trade and deal in and with real property, and any and all interests therein.
- e. To invest the capital of the company for any of the purposes aforesaid, and in the building or otherwise improving or adding to the marketable value of the lands or other properties from time to time acquired by the company.
- f. To enter into, make, perform and carry out contracts of every sort and kins with any person, firm, association, corporation, private, public or municipal or body politic and with the Government of the United States, or any state, territory or colony thereof, or any foreign government.
- g. To lend money and to negotiate and make loans, either on its own account or as agent or broker for others.
- h. In general, but in connection with the foregoing, the company may carry on any other business, whether construction, manufacturing, mining or otherwise, and have and exercise all the powers conferred by the laws of [daho upon corporations formed under the laws of said State; it being hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the general powers of the company.

The corporate powers, business and property of the company shall be exercised, conducted and controlled by the Board of Directors, who shall have the power to repeal and amend and adopt new By-laws of and for the company and to hold their meetings pursuant to the provisions of the By-laws, and at such places and at such times as the Board of Directors may, by resolution direct, or by act of the Board may fix, both within, and outside of the State of Idaho.

That the amount of the authorized capital stock of this corporation shall be **O**ne Hundred Thousand and no/100 (\$100,000.00) **D**ollars divided into **O**ne Thousand (1000) shares of the par value of **O**ne Hundred and no/100 (\$100.00) **D**ollars per share.

That the amount of said capital stock, i. e., One Thousand (1000) shares, shall be non-assessable.
