

ARTICLES OF AMENDMENT 3/17/87 3 57

**SUSAN M. GRAHAM AND ASSOCIATES, P.A.**

**FIRST:** The name of this Corporation is Susan M. Graham and Associates, P.A.

**SECOND: AMENDMENTS**

The FIRST article of the Articles of Incorporation of said corporation shall be amended by deleting it in its entirety and substituting therefor the following:

The name of this Corporation is Susan M. Graham Law Office, P.A.

The SIXTH article of the Articles of Incorporation of said corporation shall be amended by deleting it in its entirety and substituting therefore the following:

The corporate powers of said corporation shall be vested in a Board of Directors, of no less than the total number of shareholders who shall be elected and chosen as set forth in the By-Laws of this corporation.

**THIRD: DATE OF ADOPTION**

The Amendment has been approved by the Board of Directors of said Corporation at a meeting held on the seventeenth day of March, 1987, at which meeting there was at all times a quorum of the Board of Directors. The issue was submitted to a special meeting of the shareholders on March 17, 1987, at which time the corporate name change was approved.

**FOURTH: NUMBER OF SHARES**

The number of shares outstanding and entitled to a vote are 2000 shares.

**FIFTH: VOTE**

The entire 2000 shares voted in favor of this Amendment to change the corporate name to SUSAN M. GRAHAM LAW OFFICE, P.A.

**SIXTH: EFFECT ON ISSUED SHARES AND STATED CAPITAL**

The Amendment does not provide for an exchange, reclassification or cancellation of issued shares, nor does it effect a change in the amount of stated capital.

The undersigned being all of the shareholders of the corporation declare under penalty of perjury that the matters set forth in the foregoing Articles of Amendment are true and correct and that these Articles of Amendment were executed on the 18th day of March, 1987, at Boise, Idaho.
