Pursuant to the provisions of Sections 30-3-91 and 30-3-93 of the dialio Nonprofit Corporations Act, the undersigned corporation adopts the following ARTICLES OF AMENDMENT to its Article of Incorporation:

FIRST: The name of the corporation is: Southern Idaho Timber Protective Association, Inc.

SECOND: The following amendments to the Articles of Incorporation were adopted by the members of the corporation on November 10, 2005, in the manner prescribed by the Idaho Nonprofit Corporation Act.

1. Section 5.05, entitled "TERMINATION OF INTEREST" was amended to read as follows:

When an individual, firm or corporation ceases to be a member of the corporation for any cause, he or it shall receive no remuneration for any interest which he or it may claim in the property of the corporation; and the termination of membership terminates such member's interest in all the property of the corporation. Membership in the corporation gives no right, title or interest to the corporation in the land or timber holdings of any member.

2. Article 9, entitled "DISSOLUTION" was amended to read as follows:

ARTICLE 9

DISSOLUTION

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation to an organization or organizations as shall at the time qualify as exempt organizations under Section 501(c)(4) of the Internal Revenue Code, as amended from time to time, as the Board of Directors shall determine. Any assets not so distributed shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for the purposes or to such organizations, as the court shall determine to be consistent with the purposes of the Corporation.

3. A new article, to be Article 11, was added to read as follows:

ARTICLE 11

LIMITATIONS

No part of the net earnings or assets of the Corporation shall inure to the benefit of, or be distributable to, its members, Directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services

rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2 hereof. No substantial part of the activities of the Corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code, as amended from time to time.

THIRD: The amendments were adopted at the annual meeting of the membership of the corporation on November 10, 2005. The corporation has a single class of $\frac{50}{2}$ memberships outstanding, each of which is entitled to cast one vote. $\frac{5}{2}$ members attending the meeting. $\frac{5}{2}$ votes were cast in favor of the amendments and $\frac{1}{2}$ votes were cast in opposition. More than two-thirds (2/3) of the votes were cast in favor of the amendments.
