

ARTICLES OF INCORPORATION OF THE
WORLD PRINTING AND PUBLISHING COMPANY, LIMITED.

I.

We, the undersigned, all residents of the State of Idaho, under and in pursuance of the laws of said State, do hereby associate ourselves together to create a corporation for the purpose of owning, publishing and operating a newspaper and job printing plant, and we hereby agree to and adopt the following articles of incorporation.

II.

The purpose for which it is formed is to own and operate a newspaper publishing and printing plant, including a job printing plant, to acquire and own news franchises, and to buy, sell, own and hold real estate necessary or convenient for the principal objects and purposes of the incorporation.

III.

The place where its principal business is to be transacted is Weiser, Washington County, Idaho.

IV.

The term for which it shall exist is fifty years.

V

The amount of capital stock is Three Thousand Dollars (\$3,000), divided into three thousand (3000) shares of the par value of One Dollar (\$1.00) each.

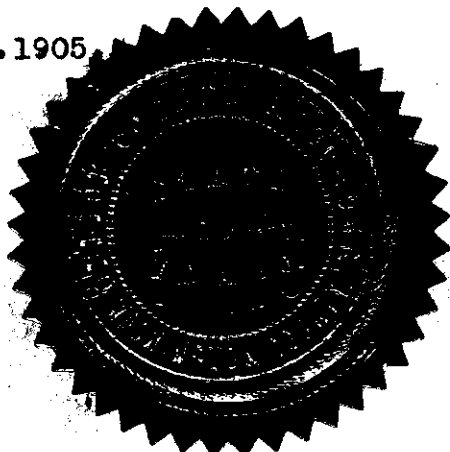
