## ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States, do hereby form a corporation under and pursuant to the laws of the State of Idaho, and do hereby certify:

I.

The name of this corporation shall be ONE ROCK FARMS, INC.

II.

The nature, objects, and purposes for which this corporation is formed shall be:

- a. To engage in the business of farming and operate farms for the production agricultural products;
- b. To lease, own, purchase, and sell equipment and or personal property of all types and nature and to acquire, buy, own, hold, sell, exchange, let or lease personal property within the state of Idaho, or outside the state of Idaho;
- c. To borrow money for the purposes of this corporation, to issue bonds, notes, and debentures and other evidences of indebtedness therefore and to secure the same by mortgage or pledge of personal property, including the income of this corporation, or by mortgage of real property, executed in trust or otherwise. All or any portion of the real or personal property of this corporation may be pledged, mortgaged or hypothecated;
- d. To build any or all buildings, structures, warehouses, or erect the same involved in the said business, and to acquire the same by purchase, lease or other means;
- e. To purchase, lease, or otherwise, acquire in whole or in part, the business, good-will, rights, franchises and property of every kind, and to take over the whole or any part of the assets or liabilities of any person, firm, association or corporation engaged in or authorized to be conducted by this corporation, or owning property necessary or suitable for its purposes and to pay for the same in cash, in the stock or bonds of this corporation, or otherwise; to hold or in any manner dispose of the whole or in any part of the business or property so acquired, and to exercise all the powers necessary or incidental to the conduct of such business:
