We the undersigned, desiring to form a non-profit cooperative association pursuant to the provisions of Chapter 10 of Title 30 of the Idaho Code Annotated, do hereby certify as follows:

ARTICLE I.

The name of this corporation shall be the HAUSER LAKE WATERSHED COALITION, INC.

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

The Registered Office is located at this address:

ARTICLE IV.

The purpose of the corporation shall be to preserve, protect and improve Hauser Lake. To promote better understanding and comprehensive management of Hauser Lake and the watershed ecosystem.

ARTICLE V.

This corporation shall have all the powers granted to general business corporations under the laws of the State of Idaho.

ARTICLE VI.

Any corporation, association, club, partnership, social group or individual may become a member of this corporation upon terms and conditions established in the by-laws and by the Board of Directors. The rights and interests of all members shall be equal and no member can have or acquire a greater interest than any other member. Membership certificates shall be issued upon terms and conditions established in the by-laws and by the Board of Directors.

ARTICLE VII.

This organization is not organized for pecuniary profit or gain. No dividend or monetary return of any kind shall be paid to the members on any basis whatsoever except in payment of just debts incurred on behalf of the corporation. No salaries of any sort shall be paid to the officers or directors. The book of account and financial records of this corporation shall always be open for inspection for any reason whatsoever to any member of this corporation. Such member or his agent shall always have the right to make copies of the account of financial records.
