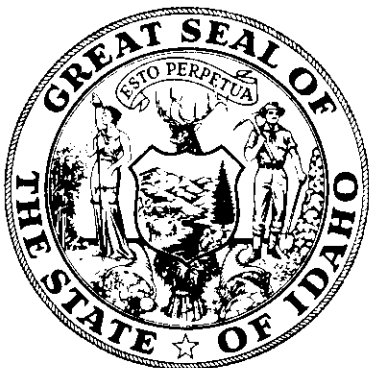

ARTICLES OF INCORPORATION

OF

G & L YORK'S OUTFITTERS, INC.

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation:

ARTICLE ONE. Name - The name of the corporation is G & L YORK'S OUTFITTERS, INC.,

ARTICLE TWO. Duration - The period of duration of the corporation shall be perpetual.

ARTICLE THREE. Purposes - The purposes of the corporation are to conduct an outfitters and guide business and to engage in any other or all lawful businesses for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE FOUR. Powers - This corporation shall have all of the powers conferred by the Idaho Business Corporation Act.

ARTICLE FIVE. Stock - The total authorized number of par value of stock is 1,000. The aggregate par value of the total authorized number of par value shares is \$1,000.00. Such shares shall be all of one class, to be known as common stock, and all shares shall be non-assessable.

ARTICLE SIX. Preemptive Rights - The preemptive rights of shareholders to acquire additional shares of the corporation shall be as provided under the Idaho Business Corporation Act.

ARTICLE SEVEN. Directors - The number of directors constituting the initial board of directors is TWO (2), and the names and addresses of the persons

who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualify are: GLADYS L. YORK, Route 1, Lenore, Idaho, 83541, and LEON A. YORK, Box 355, Elk City, Idaho, 83525.

ARTICLE EIGHT. Incorporator - The name and address of the incorporator is Gladys L. York, Route 1, Lenore, Idaho, 83541.

ARTICLE NINE. Registered Office and Registered Agent - The registered address of the initial registered office of the corporation shall be 1111 F Street, Suite B, City of Lewiston, County of Nez Perce, State of Idaho, 83501.

The initial registered agent of the corporation at such address shall be Robert L. Brower.
